

Council Meeting for June 8, 2009

The Graettinger City Council met in regular session Monday, June 8, 2009 at 7:00 P.M. at City hall with Mayor Hanson presiding. Present were council member McGrauth, Smith, Flaherty, Anderson and Skattebo. Present were city employees Henderson, and Murray.

Motion by Anderson, second by Smith to approve consent agenda.

1. Motion to approve agenda.
2. Motion to approve minutes.
3. Motion to approve bills.
4. Motion to approve financial statement.
5. Motion to approve liquor license for Graettinger Veterans Club pending dram shop.
6. Motion to approve cigarette permits for Graettinger Market and Graettinger Country Store. All ayes. Carried.

Tabled ordinance for rates outside the city limits.

Kenny Gilbaugh was present regarding concerns of dandelions at the cemetery and requested the city to spray every year. Motion by Skattebo, seconded by McGrauth to have Murray hire someone to spray the cemetery this fall. All ayes. Carried.

Lloyd Petersen, representing Graettinger Economic Development was present asking for TIF money of \$25,000 for 5 years. Tabled any action regarding the TIF money until more information could be obtained from the bonding attorney.

Motion by McGrauth, seconded by Anderson to proceed with issuing a citation to Mark and Tonya Feldhacker for an illegal connection to the cities water system without the cities permission. All ayes. Carried.

Mayor Hanson, Anderson and Flaherty excused themselves from the meeting at 8:50 P.M.; do to conflicts of interest regarding the opening of bids for the shelter house. Mayor Pro tem Smith then opened bids for the shelter house, with the following bids:

Anderson Construction-\$29151.93, with proof of insurance

Merle T. Hanson-\$31147.32, with proof of insurance

Diamond Builders-\$21083.86, no proof of insurance, bid rejected.

Motion by Skattebo, seconded by McGrauth to accept the bid from Anderson Construction for the addition at Citizen's Memorial Shelter house for \$29151.93. Ayes-3. Motion carried. Mayor Hanson, Anderson and Flaherty present at 9:50 P.M.

Motion by Skattebo, seconded by Anderson to give Kroenke, Murray, Petersen, and Henderson a 2% raise for a total of \$799.06 effective July 1, 2009. All ayes. Carried. Flaherty introduced resolution no. 11-2009, "A resolution setting salaries for employees of the City of Graettinger", and moved that it be adopted. Seconded by Smith. All ayes. Carried
