

Council Meeting for January 8, 2024

The Graettinger City Council met in regular session Monday, January 8, 2024, at 6:00 P.M. at city hall with Mayor Armstrong presiding. Present were council member Masters, Dyhrkopp, Alderson and Harris. Employees Henderson, Anderson, and Petersen.

Motion by Dyhrkopp, seconded by Alderson to approve consent agenda. 1. Motion to approve agenda. 2. Motion to approve minutes. 3. Motion to approve bills. 4. Motion to approve financial statement. 5. Motion to approve Class B Alcohol License for The Graettinger Market All ayes. Carried.

Megan and Alex Helmick, Paulina Chavez and Irving Ahumada were present asking for permission to apply for the catalyst grant for a new business on Robins Street, in which this grant would renovate an old building. The council gave them permission to apply for the grant.

Discussion was held on replacement of the Odorator methane gas detector. The detector cannot be calibrated. Motion by Dyhrkopp, seconded by Alderson to authorize Petersen to purchase an Odorator 2 Methane gas detector for the Gas Utility. All ayes. Carried.

Motion by Alderson, seconded by Dyhrkopp, to accept Tug Helmers' bid to repair the some corners of the bathhouse and floor for a cost of \$1950. All ayes. Carried.

Gina Hall and Leslie Faust reviewed the budget for fiscal 2024-25 and asked for an increase in the general fund and employee benefit fund for additional expenses. The Council will consider this at their budget meeting on the 29th of January 2024.

Masters introduced resolution no. 1-2024, "A resolution authorizing the city clerk to make payments for certain bills received after the regular council meeting" and moved that it be adopted. Seconded by Dyhrkopp. Ayes-4. Adopted.

Dyhrkopp introduced resolution no. 2-2024, "A resolution approving the bank depository", and moved that it be adopted. Seconded by Alderson. Ayes-4. Adopted.

Dyhrkopp introduced resolution no. 3-2024, "A resolution approving the investment policy for the City of Graettinger" and moved that it be adopted. Seconded by Harris. Ayes-4. Adopted.

Regular council meeting is set for the 2nd Monday of the month at 6:00 P.M. at city hall. Alderson introduced resolution no. 4-2024, "A resolution setting the time and place for a regular council meeting" and moved that it be adopted. Seconded by Dyhrkopp. Ayes-4. Adopted.

Dyhrkopp introduced resolution no. 5-2024, "A resolution designating the Graettinger Times as the official newspaper for publications" and moved that it be adopted. Seconded by Harris. Ayes-4. Adopted.

A rate change to \$9.50 for Harris Sanitation customer effective February 1, 2024, was discussed. Alderson introduced resolution no. 6-2024, "A resolution setting fees for Harris Sanitation for garbage service and approval of contract." and moved that it be adopted. Seconded by Dyhrkopp. Ayes-3. Abstain- Harris. Adopted.

Funds for self-insurance were transferred into the general fund for fiscal 2022-23 and needed to be put in the Self-insurance fund. Dyhrkopp introduced resolution no. 8-2024, "A resolution authorizing a transfer for correction to self-insurance fund." and moved that it be adopted. Seconded by Alderson. Ayes-4. Adopted.

Motion by Dyhrkopp to remove Michael Flaherty from Bank Plus privileges and add Brandon Armstrong mayor for the privileges, effective January 1, 2024. All ayes. Carried.

Discussion was held on the vacancy seat of council member Armstrong position and instructed the clerk to publish a notice in the Graettinger times. Notice is hereby given that there is a vacancy for the office of the city council due to the resignation of Brandon Armstrong, whose term expires on December 31, 2025. The city council of the City of Graettinger intends to fill this vacancy by appointment until the next city election. However, if within fourteen days after the appointment, there is filed with the city clerk a petition which requests a special election to fill the vacancy, an appointment to fill vacancy is temporary and the city council shall call a special election to fill the vacancy permanently. If anyone is interested in the position, contact City clerk Kara Currans for details regarding the vacancy.

Discussion was held on rate for the garbage collection for residents of the City of Graettinger. Motion by Alderson, seconded by Masters to set a rate of \$16.50 per month for residential garbage. All ayes Carried. Masters introduced Ordinance no. 230 " An Ordinance amending the code of ordinances of the City of Graettinger, Iowa, 2024, by amending provisions pertaining to Solid waste collection fees". Then said ordinance was read and discussed. Motion by Masters, seconded by Dyhrkopp to approve the first reading. Ayes-4. Carried. Motion by Alderson, seconded by Masters to waive the rule requiring said ordinance be read at three separate meetings and move that it be adopted. Ayes-4. Motion carried.

Mayor Armstrong reviewed the City of Graettinger Organizational Chart for 2024. Nate Harris will be appointed to the open committee seat vacated by Brandon Armstrong.
